"Keri Ninness is leading the Walking with Moms in Need initiative at St. Joseph Church in Marietta, Georgia. 'This is a call to arms. ... We have to put our money where our mouth is,' she told Our Sunday Visitor. 'Now what? The baby is saved and born. We must provide services for mom and baby like child care, baby formula, perhaps adoption planning, housing and more. Whatever the need is, we are coming along beside you, and we will help you.' The response of Ninness' parish to the call to participate in the initiative 'is beyond anything I can dream,' she said. 'Families have jumped to help. ... We have a thriving life ministry. These parishioners have prayed for this (overturning Roe) and provided prayer in action. Now, we're taking it to the next step. We understand, when a

woman is facing an unplanned pregnancy, that it is anything but simple, it is anything but easy. It is hard, and it is complex. We want women to feel respected, loved and supported."
