### **The Verge: Judge blocks Mississippi law that required age verification on social media**

"We appreciate the court's thoughtful and speedy review of this matter, but respectfully disagree that the Constitution blocks the State's effort to protect children online," **Mississippi Attorney General Lynn Fitch** said in a statement. "We will continue to fight for this commonsense law because our children's mental health, physical security, and innocence should not take a back seat to Big Tech profits."

### **WTVA: Mississippi Attorney General launches next phase of anti-human trafficking campaign**

Mississippi's attorney general launched the third phase of her "Be The Solution" campaign. Republican Attorney General Lynn Fitch held an event on Monday in Tupelo. It is a statewide education and awareness campaign to help Mississippians identify, report and end human trafficking. The third phase

focuses on medical, mental health and child advocacy.
