# A Note from AG Lynn Fitch

Earlier this month, my office went to the Fifth Circuit Court of Appeals to defend the Walker Montgomery Protecting Children Online Act after Big Tech sued Mississippi to stop this commonsense law from taking effect. The law has a few key provisions that require social media platforms to do what any responsible company already would do: make commercially reasonable efforts to protect minors. That's it. Just reasonable efforts to lend a little help to parents who feel helpless to protect their children online.

Mississippi is also one of 42 states that have taken social media companies, like TikTok and Meta, to court. The evidence we have acquired through our investigation is staggering. The companies knew that they were causing harm to their minor consumers. Not only did they not address the harms, but they intentionally fed them increasingly addictive products. Our children were profit-making machines, and they were going to suck every dollar out of them, even if it left those children empty, hurting and damaged.

I will continue to stand up to Big Tech in order to protect our children and provide parents with the tools they need to keep their families safe. We have made a lot of progress, but the work to support families and provide them with the resources they need to flourish with this Empowerment Project agenda is only just beginning.



"In this one operation, we seized enough fentanyl to kill 8,580 people," said **Attorney General Fitch.** "But we only scratched the surface of the poison being peddled to our children. We are grateful to our federal, state, and local law enforcement partners who worked with us on Operation Game Over and who are a part of our task force network, including the Human Trafficking Task Force and Fentanyl Strike Force."

AG Fitch was joined by local law enforcement and university officials for her "One Pill Can Kill" campaign, making students aware of the rise in fentanyl trafficking, and how fentanyl can be laced in other drugs. They're trying to keep these drugs off the street because the intention is to get it out into our community."
