"My office is committed to taking criminals who traffic people off the streets and equally committed to setting victims on the road to recovery," said Attorney General Lynn Fitch. "We are grateful to our federal, state, and local law enforcement partners who worked with us on Operation 806 and who are a part of our task force network."

WDAM- MS Attorney General warns Mississippians of the dangers of unapproved weight loss medication

"It is critical that consumers remain vigilant and ensure that they are purchasing safe, regulated weight loss drugs," **said Fitch**. "I urge Mississippians to work with their licensed prescriber and pharmacist when taking these prescription medications and to purchase them only from a licensed and regulated source. If you think you have purchased an unapproved product, please report it to my office."

"For years, Mississippi's independent pharmacies have been forced to take artificially low reimbursements because the PBMs have used their influence and leverage to effectively force non-negotiable contracts on them," **Fitch said in a statement**. "These small business owners are already operating on razorthin profit margins."

"This is wrong. And it is against Mississippi law," **Fitch said**. "Mississippi is fighting back and we achieved an important victory."
