### **WAPT - New app collects reports of human trafficking, State AG announces Simply Report app**

A new app is available in Mississippi to help report human trafficking. **Mississippi Attorney General Lynn Fitch** announced Simply Report.

The Simply Report app provides a streamlined tool for users to recognize and report indicators of trafficking directly to the appropriate authorities, bridging the gap between community awareness and actionable intervention. Simply Report is intended to ensure compassionate, context-aware decisions that direct viable leads to the proper authorities.

**Attorney General Lynn Fitch** joined her colleagues from across the country in Yuma, Arizona to visit the Southern Border.

The **Mississippi Attorney General's Office** is the only agency in Mississippi currently participating in the program by training and certifying all of its sworn law enforcement officers as members of the 287(g) Task Force.

"I have had the honor of working with the Children's Advocacy Centers of Mississippi, Child Protection Services, law enforcement, prosecutors, judges, and other vital stakeholders to develop this Statewide Protocol for Child Abuse Response to provide a consistent, victim-centered approach for all the professionals who work on felony child abuse cases."

"Every person in this network brings unique knowledge to the table, and this protocol represents a unified, multidisciplinary approach to child abuse cases.

It outlines best practices for professionals across fields to follow – from investigators, prosecutors, and judges to therapists and healthcare providers.

Most importantly, it is a blueprint to ensure that every child in every county receives a consistent, child-focused response that shows child-victims that despite all that the abusers took from them, they are loved, valued, respected, and protected," **said Attorney General Lynn Fitch** in her op ed for South MS Living Magazine.

"WeChat has become a haven for bad actors to traffic drugs and launder money behind a screen," said **Attorney General Lynn Fitch**. "This Chinese-owned app is helping criminals push fentanyl in our communities.
