My office will continue to fight to preserve the integrity of women's athletics, and I am thankful to be joined by my colleagues from across the country, as well as the Trump administration as we support our girls and restore the honors that they rightfully earned. I am proud to support these incredible women in the fight to protect privacy, safety, and opportunity.

WLOX - Gulfport welcomes second Safe Haven Baby Box: 'You can't put a price on life'

A new "Safe Haven Baby Box" has been installed in Gulfport, Mississippi, making it the second in Gulfport and eighth in the state.

These devices allow parents to safely and anonymously surrender their baby up to 45 days after a child's birth without legal consequences. House Bill 1813 made this possible in 2023.



With over 4,000 children in foster care in Mississippi, the need for foster homes is evident.

Yet, policy is changing to better serve Mississippi foster children and families. New guidelines from the Mississippi Department of Child Protection Services allow for more flexibility and support of foster children and families. For example, foster parents can now complete their foster care training hours completely online. Additionally, the Mississippi Department of Child Protection Services plans to soon introduce a foster parent advisory council in which foster parents can contribute feedback to.

"We've been going after human traffickers, sex-offender registry, trying to make sure they're in compliance, and trying to get the drug dealers of fentanyl, and we've had about 400 local, state, and federal law enforcement partners that have helped us in all these five different locations across the state," **Mississippi Attorney General Lynn Fitch** told The Daily Signal.

Operation Guardian Force ran from July 14 to July 29. Perpetrators were charged with crimes including human trafficking of a minor, child exploitation, promoting and procuring prostitution, 28 various felony narcotics charges, failure to comply with sex offender registry, and felon in possession of a
