Suitcase Bundling for Foster Children in Mississippi

Last week, I was honored to welcome members of the Trump administration and Focus on the Family here in Mississippi for a service project packing 1,350 suitcases for children in foster care. Over 150 volunteers from State agencies participated by filling rolling suitcases with stuffed animals, age-appropriate Bibles, and handwritten notes of encouragement. The suitcases and items packed inside were donated by Focus on the Family through their Wait No More Suitcase Bundle Program.

Children in foster care face unique challenges, often entering the system with very few personal belongings and a great deal of uncertainty. By providing them with something they can truly call their own, we are offering more than a tangible item; we are offering a sense of stability and dignity. [The Yazoo Herald - AG Fitch Announces Sentencing for Felony Desertion](#)

Attorney General Lynn Fitch announced the sentencing of Corey Outland, 43, of Ridgeland, Mississippi, on one count of felony desertion for failing to pay over \$31,500 in past-due child support. This case was investigated and prosecuted by the **Mississippi Attorney General's Office**, with assistance from the Madison County Sheriff's Department.

"Parents have a legal and moral obligation to provide for their children, and we will continue to hold those who fail to do so accountable," **Fitch** said. "I am grateful for our AGO prosecutors and investigators and our law enforcement partners who are committed to ensuring that Mississippi's children receive the support they deserve."

Attorney General Lynn Fitch announced the sentencing of a Brookhaven man in a nearly \$1 million wire fraud case that targeted Mississippi investors. 23-year-old David Tiler Castillo was sentenced to 40 months in federal prison after pleading guilty to one count of wire fraud. U.S. District Judge David Bramlette handed down the sentence on Jan. 13, which also includes three years of supervised release following imprisonment.

WLBT - Romanian national sentenced in card skimming scheme across multiple Miss. counties

A Romanian national was sentenced in a card skimming scheme spanning multiple Mississippi counties, **Attorney General Lynn Fitch** announced.

The suspect, identified as Antonio Rafaila, was charged on one count of illegal possession, production, or trafficking in device-making equipment for the placement of skimmer devices on credit card readers in stores across Jones County, Madison County, and Laurel.

The Mississippi Attorney General's Office investigated this case, receiving assistance from the Madison Police Department, Texas Financial Crimes Intelligence Center, and the United States Secret Service.

WJTV - AG Fitch announces Phase 2 of robocall crackdown

Attorney General Lynn Fitch (R-Miss.) announced Phase 2 of Operation Robocall Roundup, which is a multistate effort by the Anti-Robocall Litigation Task Force to crack down on robocalls across the country.

As part of an ongoing investigation, the bipartisan Task Force directed Inteliquent, Bandwidth, Lumen, and Peerless to stop transmitting suspected illegal robocalls across their networks.
