### WLBT - Amazon donates 1,000 doorbell cameras to the Mississippi Coalition Against Domestic Violence

On Monday, Amazon announced it's donating 1,000 Ring devices to the Mississippi Coalition Against Domestic Violence — devices that will go directly to survivors as they transition to independent living.

"When violence is inflicted upon a person by someone they trust, someone that they depended on, someone they loved, it scars them more than just physical," **Fitch** said.

"It certainly takes an emotional toll on them, and it also tears away their sense of security. Anything that we can all do that helps restore their sense of security, their safety, and their peace of mind is so important."

### Darkhorse Press - Fitch Joins Bipartisan Call for Congress to Pass Kids Online Safety Act

**Mississippi Attorney General Lynn Fitch** joined a bipartisan coalition of attorneys general Tuesday in urging Congress to pass the federal Kids Online Safety Act, warning that social media platforms pose growing threats to children's physical and mental health.

"Social media platforms promise connectivity, but that is not without consequences," **Fitch** said in a statement. "These platforms pose serious physical and mental health risks to our children. Parents are desperate for help because they are up against the best digital engineers with the unlimited resources of their social media cartel employers."

In the wake of winter weather that has impacted the State, **Mississippi Attorney General Lynn Fitch**, Mississippi Insurance Commissioner Mike Chaney, and the Mississippi State Board of Contractors (MSBOC) warn of common scams and share tips for Mississippians to protect themselves against fraud.

### DeSoto County News - Fitch targets gangs with new legislation

**Attorney General Lynn Fitch** is calling on state lawmakers to pass a pair of bills aimed at dismantling gang activity and curbing juvenile gun violence across Mississippi.

The proposed legislation, HB 1165 and SB 2710, seeks to shift jurisdiction for certain firearm-related offenses involving minors to circuit courts. The bills also propose stiffer penalties for the transfer of stolen firearms and establish a new criminal penalty for discharging a weapon into a crowd.
